ALERT: SAVE WIA I CAMPAIGN. The National Skills Coalition (NSC) is actively coordinating a campaign to preserve federal funding for WIA Title I and other vital federal workforce programs which face Congressional cuts or elimination. CAAL is one of several dozen adult education and workforce development organizations that have signed onto the effort. The NSC campaign includes meetings and letters, and most recently, NSC and a group of other national organizations called for a "Workforce Day of Action" for Thursday, March 24, 2011. Groups with a stake in the outcome are being urged to call on their local and national elected officials to voice their opposition to any cuts or elimination of of funding for WIA Title I and other workforce development programs. <u>Employer-Valued Postsecondary Education</u> is new from the Center for Law and Social Policy (CLASP). This 17-page publication, written by Marcie Foster, Julie Strawn, and Amy Ellen Duke-Benfield, suggests state policy strategies to increase the enrollment and success of adults and out-of-school youth in further education and job training programs. As the title indicates, the focus is on connections between basic skills and postsecondary education and adult learners who need different kinds of interventions than traditional age students.

**COMPLETE COLLEGE AMERICA** has launched a \$10 million competitive grant program to help states develop innovative statewide strategies to increase college completion. The project is funded by the Bill & Melinda Gates Foundation. State applicants must indicate their "intent to apply" by sending an email with that subject line to <u>innovation.challenge@completecollege.org</u> by March 18, 2011. **GED TESTING SERVICE**, a program of the American Council on Education (ACE), today became a program of a new joint venture between ACE and Pearson VUE. The purpose of the partnership is to design and deliver a computer-based GED test, aligned with the Common Core State Standards. Computer-based versions of the current GED test will be rolled out gradually in official testing centers across the country, with the service to be available in California, Florida, Georgia, and Texas sometime this Spring. A new version of the GED test will be implemented by 2014. The GED Testing Service name will be retained. The overall goal is position the GED to contribute more to the national effort to move more adults to college and job readiness. Pearson is an international test development and data management company. ACE is the major coordinating body for the nation's higher education institutions and provides an array of policy, research, and advocacy services.
